**A RESOLUTION ACCEPTING THE CANVASSING OF THE
GENERAL/SPECIAL; ELECTION HELD ON MAY 1, 2021**

WHEREAS, in accordance with the law, a General/Special Election was duly called, notice given thereof and held on Saturday, May 1, 2021; and

WHEREAS, on this date, Monday, May 10, 2021, the City Council of the City of Eagle Pass has convened in special session to canvass the returns of said election; and

WHEREAS, in accordance with the law, the City Secretary posted written notice of the date, place and subject of this meeting on the bulletin board located in the lobby at City Hall, a place convenient and readily accessible to the general public, said notice having been posted and remaining posted continuously for at least 72 hours preceding the scheduled time of said meeting, a copy of the return of said posting being attached to the minutes of this meeting and being made a part thereof for all intents and purposes; and
